**Notice of Variation - Extension of offer period - Notice of the new date for giving notice of the defeating conditions**

We act for Oasis Star Limited (**Oasis Star**) in relation to its off-market proportional takeover bid to acquire 80% of the ordinary shares in Tian An Australia Limited ACN 009 134 114 (**Tian An Australia**) that it does not own (**Offer**).

Oasis Star announces today that it has agreed to vary the Offer by further extending the period during which the Offer will remain open so that the Offer will now close at 7pm (Sydney time) on 1 December 2017 (unless extended).
