
Note :

On 12 December 2017, TIA announced that the off-market proportional takeover offer (the "Offer") by Oasis Star Limited ("Oasis Star") for 80% of shares in TIA that Oasis Star does not own for AUD\$1.3 cash per Share has completed (the "Completion of the Offer").

Eminent Star Ventures Limited, a wholly-owned subsidiary of Many Merit Asia Limited ("MMA"), has accepted the Offer and its interest has been decreased in TIA from 10.97% to 2.2% after the Completion of the Offer. Mr. Lin held 3.46% interest in TIA and Mr. Lin maintains 100% interests in MMA. Therefore, MMA and Mr. Lin have a deemed relevant interest in TIA.
